# REPORT OF THE NATIONAL PRESIDENT January 29 to May 6, 2022

The bulleted matters listed above, describe activities I normally take on, monthly on average, and I extend appreciation to Jaison Van Tine to pick up the other responsibilities within UNE, along with Johanne MacAndrew for making the attempt to maintain cohesion in my scheduling.

I will be emphasizing a few matters during this period.

# The waves of the pandemic, and the variants of the Covid-19 contagions:

There are many anxieties about our membership wanting the end of the waves of the current pandemic. Anxieties also exist regarding returning to a workplace and attestations ensuring safe workplaces.

There is also hope of members continuing working from home, either permanently, or in a hybrid model of a home and office environment. Extensive consultation with employers, and a full return to whatever workplace condition will require continuing and extensive consultation with employers.

This will be a critical period in our membership history to manage expectations of our membership.

Additionally, there is a belief that the variants of this contagion are not over, and people continue to worry about compromised immune systems, and this concern must also be considered.

There is a possibility that this contagion and its variants will not be eliminated in the foreseeable future, and that our global society will have to adapt to living with a contagion that knows no borders or social economic barriers.

There will be more to discuss in future reports, but many careful conversations will be needed to be had with locals and local membership regarding all facets regarding reporting for work, and the future of work.

### **UNE Membership Concerns – Union Cards:**

The pandemic has been terribly unkind to national and local leadership to connect with member locals, and to ensure orientation and signing of new members.

Additionally, there are still gaps in communication with respect to which bargaining units have the capability to sign electronic cards, which could, in theory, be easier, but a lot have not had an online tutorial with respect to signing a card electronically.

Half of our component still has a card check system, because certain labour boards do not allow electronic cards, which means that if the groundwork is not done, numbers of rand deductees will continue to decline, from 20 percent in 2008, and now approaching 36 percent in 2022.

With respect to unallotted membership, those who are not currently assigned in our component, number more than 1100 members with PSAC Membership Branch as of March 2022.

This will be the challenge of the remainder of this cycle, and in the next UNE Convention cycle of 2024-2026, to have a committed goal to get our membership signings up to a value of 85% of our membership signed, regardless of which bargaining unit they belong to. Yes, this will take real work, and something that can't be "just mailed in".

#### **PSAC Convention Committee matters:**

I wish to express appreciation to Jaison, Hayley and Ellen, for participation in the four PSAC pre-Convention committees (Finance, Collective Bargaining, General, and Constitution).

The business week was extended by a couple of days, including committee priorities, and in a virtual environment, I found the work more cumbersome than previously experienced.

It is extremely difficult to get resolutions through a convention committee, and very difficult to move progressive ideas forward, or as a big ship with an awfully small propeller and an even smaller rudder.

#### **PSAC Convention 2022:**

UNE has its smallest number of convention delegates that I can recall. Our membership has increased by three thousand, and yet, our membership status, as PSAC Convention delegation has diminished by 7, or 15%. Our component will have severe challenges maintaining our delegate count to our parent convention, if signed members retire and membership engagement does not connect with newly or currently unionized members.

#### This mandate:

This convention cycle has a completely differing dynamic than the previous cycle, because of how fast time seems to be going by...Months seem to go by in weeks, and it is hard to keep up and keep obligations made at the previous convention.

We had to postpone a youth conference to this next cycle and set aside the women's conference until the next cycle, two less opportunities to connect face to face with our activists.

There is hope, anxiety, and some excitement with respect people getting together again. Our membership hopes for a normal return to our business, in all its forms, as compared to managing day to day operations; managing contingencies, as compared as talking on screen, diminished interactions, and making and keeping good connections with membership.

As mentioned previously, it is most unusual conducting business in a pandemic, and it is not natural to be speaking on screen as compared to being present and in the moment. It is easy for some to be on screen, and for others, it provides a challenge that are very difficult to overcome. I thank our staff, our leadership, our locals, for making themselves available to assist membership in the difficult posture, where assisting by platform or by phone, seems counter intuitive to assisting in person.

Thank you to all UNE staff, and to our nationally and regionally elected leadership for assistance during this period. My interactions are appended.
