A) Bargaining Updates

lan Martens advised that the Canadian museum for human rights will start negotiations for a new collective agreement soon.

They set the terms and conditions of employment, such as pay and leave, for employees in that bargaining unit.

Michael Freeman advised that the agreement for the federal public service workers under the Treasury Board of Canada - Program and Administrative (PA) Services – is set to expire in June 2025.

It was noted that the collective agreement for Parks Canada members was ratified on August 4, 2023 and signed on September 26, 2023. It is set to expire August 4, 2025.

C) <u>UNE Conferences</u>

Alisha Campbell advised that the call out for Young workers conference will soon be sent out. Members who are 35 years or younger are eligible to participate. If someone in your Local meets the criteria please encourage them to participate.

13. NEW BUSINESS

D) Referrals to Committees

Alisha Campbell advised that items could be referred to a committee as follows:

E) Update on UNE Administration

Alisha Campbell advised that our Administrators are still supporting us on the operational side to ensure a smooth transition once we came out of trusteeship and move towards exiting the Administration. A motion will be placed on the agenda of the NBoD for the March meeting regarding ending the period of UNE's Trusteeship and Administration.

B) Conversion from SSO to PA Group

F) <u>Local 70405</u>

It was agreed that this item be referred to the Local and Governance Committee with the following instruction:

"That the Union of National Employee approves the creation of Composite Local 70405, consisting of all PSAC members employed by SeedChange and all PSAC members employed by Farmers for Climate Solutions, and that this local subscribes to, and accepts as its governing documents, the Constitution of Public Service Alliance of Canada and the bylaws of the

Union of National Employees."

G) <u>Devolution in Nunavut</u>

A discussion was held with respect to the final devolution agreement, transferring responsibilities for Crown land and natural resources from the federal government to the Nunavut government and the potential impact on UNE members. It was noted that the Nunavut Employees Union and the UNE will work together to insure smooth transition for our members.

H) Changes to the Employment Equity Act

Hayley Millington highlighted some of the long-overdue changes of the Employment Act review as follows:

- 1. The inclusion of Black and 2SLGBTQ+ communities as employment equity groups;
- The use of disaggregated data for all equity groups;
- 3. The replacement of outdated terminology with updated and appropriate language;
- 4. The creation of an independent Office of Equity Commissioner: This office would curb the current limitations that federal public service workers encounter when filing complaints through the Canadian Human Rights Commission (CHRC);
- 5. The establishment of Joint Employment Equity Committees with detailed roles and responsibilities;
- 6. The inclusion of employment equity into collective agreements, including provisions that enable for the negotiation of employment equity that go above and beyond the requirement under the EEA;
- 7. Elevating the EEA to quasi-constitutional status which will strengthen the Act and meaning that provisions in the Act will now take ensure it takes precedence over the Public Service Employment Act and the Financial Administration Act.

I) The UNE Office

Alisha Campbell advised that a first in person all UNE staff meeting was held in early January. We also resumed all directors' meetings, and we are delighted to report that things are going well.
